## LAND USE PLAN RATIFICATION VOTE

**TAKE NOTICE THAT** the Shuswap Indian Band has called a Ratification Vote in accordance with the *Shuswap Indian Band Land Code (2014)* to be held on **October 29, 2020** to determine if eligible voters support the following **YES/NO** question:

*Do you approve of the Shuswap Indian Band Land Use Plan (2020) dated October 2020?*

**NOTE THAT** the proposed *Shuswap Indian Band Land Use Plan (2020)*, dated September 2020 will be considered approved if a majority of eligible voters that participate in the vote approve the proposed land use plan.

**Any Registered Voter may vote In Person, by Mail-in Ballot or Electronic Ballot.**


